ACCOUNTANT'S REPORT: Monthly Financial Report – Lauterbach & Amen, LLP: Mr. Flessner presented the Monthly Financial Report for the period ended December 31, 2016. As of 12/31/16, the plan net held in trust for pension benefits is \$44,206,180.57, with a net change in position for the seven month period of \$1,868,096.49. The Cash Analysis Report, Revenue Report, Expense Report, Member Contribution Report and Payroll Journal were reviewed with the Board. All questions were answered by Mr. Flessner.

**INVESTMENT REPORT:** Sawyer Falduto Asset Management, LLC: Mr. Falduto and Mr. Sawyer presented the Investment Report for the period ending December 31, 2016. As of 12/31/16, the ending market value of the Fund is \$43,846,415 with an investment return for the quarter of 0.46% net of fees, outperforming the policy benchmark of 0.42%. The investment return for the year is \$2,713,046. The current portfolio allocation is 51.8% in Equities, 46.8% in Fixed Income and 1.4% in Cash and Equivalents. The Market Commentary, Equity Portfolio, Fixed Income Portfolio and Transactions Report were reviewed with the Board. All questions were answered by Mr. Sawyer and Mr. Falduto. A motion was made by Trustee Schlicher and seconded by Trustee Super to accept the Investment Report as presented. Motion carried unanimously by voice vote.

Review/Update Investment Policy: There were no updates to the Investment Policy at this time.

**COMMUNICATIONS OR REPORTS:** *Trustee Training Update:* The Board reviewed the Trustee Training Summary and discussed upcoming training opportunities. Trustees were reminded to submit any training certificates to Lauterbach & Amen for recordkeeping.

Statements of Economic Interest: Trustee Walker informed the Board that the List of Filers for the annual Statements of Economic Interest were submitted by the February 1, 2017 due date. Trustees will be contacted directly to complete the Statements of Economic Interest by the deadline of May 1, 2017.
