

ORDINANCE NO. 2017-09

**ORDINANCE LEVYING AND ASSESSING TAXES OF
ADDISON FIRE PROTECTION DISTRICT NO. 1
DUPAGE COUNTY, ILLINOIS FOR 2017**

BE IT ORDAINED by the Board of Trustees of the Addison Fire Protection District No. 1
as follows:

SECTION ONE: That the sum of **THIRTEEN MILLION, SIXTY HUNDRED AND TWENTY SIX THOUSAND AND THREE DOLLARS AND 00/100 (\$13,626,003.00)** be assessed and levied from and against all taxable property within the limits of the said Addison Fire Protection District No. 1 as the same is assessed and equalized for State and County purposes for the current year 2017 and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:




