Call to order

Brian Smith called to order the regular meeting of the Foreign Fire Tax Insurance Board at 09:43 on April 17, 2019.

Minutes from the previous meeting were read and the motion to approve was made by F/M LoBello, and seconded by All were in favor. None opposed

I. Treasurer's Report

- a) Due to the treasurer having an unforeseen absence, this was tabled for the next meeting. Board discussed all expected expenses and we were to have an estimated \$120,000.00 Lt.Smith made the motion and FF/PM Gerlich. All were in favor. None opposed.

- b) A request was made by Lt. Smith to split the refrigerator cost with the district. A request was made for the FFTIB to pay half the cost not to exceed \$300. This was to replace the broken unit at station 71. FF/PM LoBello made the motion to approve the expense and FF/PM Gerlich second. All were in favor, none opposed.
- c) A request to add hose testing to the agenda was made by Lt. Hamm. This was already approved by the FFTIB at the last meeting at a value not to exceed \$6000.00 No further action needed by the FFTIB at this time.
- d) A request by FF/PM Gerlich to pay to repair the recliners at station 71 and 72, and purchase an additional recliner for station 71 due to more personnel. After discussion it was decided by the board it wouldn't be cost effective to pay for all the repairs and a motion was made by FF/PM LoBello to purchase all new chairs with the additional chair at station 71 not to exceed \$14,000, and this was second by BC Pluta. All were in favor, and none opposed.
