# ORDINANCE LEVYING AND ASSESSING TAXES OF Page County Clerk ADDISON FIRE PROTECTION DISTRICT NO. 1 DUPAGE COUNTY, ILLINOIS FOR 2019

BE IT ORDAINED by the Board of Trustees of the Addison Fire Protection District No. 1 as follows:

SECTION ONE: That the sum of FIFTEEN MILLION, NINE HUNDRED AND EIGHTY EIGHT THOUSAND, SEVEN HUNDRED AND SIXTY TWO DOLLARS AND 00/100 (\$15,988,062) be assessed and levied from and against all taxable property within the limits of the said Addison Fire Protection District No. 1 as the same is assessed and equalized for State and County purposes for the current year 2019 and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

# ADDISON FIRE PROTECTION DISTRICT NO. 1 TRUTH IN TAXATION CERTIFICATION

I, MICHAEL J. SUPER, hereby certify that I am the chief presiding officer and President of the Addison Fire Protection District No. 1, DuPage County, Illinois, and as such, I hereby certify that the District's 2019 tax levy ordinance, a copy of which is attached hereto, was adopted pursuant to, and in all respects in compliance with, the provisions of Sections 18-60 through 18-85 of the Truth in Taxation Law, 35 ILCS 200/18-60 through 18-85.

The District levied an amount that is greater than 105% of the final aggregate extension plus any amount abated prior to extension for the 2018 tax levy, therefore the publication and hearing provisions of the Truth in Taxation Law are applicable and have been met.
